Example: Validation on the value of a Cascading Select field

- 1. I have an issue type INCIDENCIA
- 2. I have a custom field of Cascading Select type named "Área/Subárea".
- 3. The correct values for "Área/Subárea" area:
 - a. Servicios No Planificables/Incidencias
 - b. Servicios No Planificables/Servicios
 - c. Servicios No Planificables/Cambios
 - d. Proyectos/Proyectos menores
- 4. I need to validate that an issue of "INCIDENCIA" issue type cannot be created if "Área/Subáreea" is not equal to "Servicios No Planificables/Incidencias"
- 5. I have defined in INCIDENCIAS workflow

If you use Boolean validator with math, date-time or text-string terms you have to use the following configuration:

Note that:

Field code for field "Área/Subárea" is %{13700}.

This field code depends on each Jira instance. You can find the code for you particular Jira instance in the field list available the validator configuration screen.

Other examples of that function

Boolean validator with math, date-time or text-string terms

Page: Block a transition until all sub-tasks have certains fields populated Page: Block an epic's transition depending on linked issues status and due date

Page: Block or hide a transition for an issue depending on its issue links Page: Block or unblock a transition after an issue rested a specific time in a status

Page: Block transition until all sub-tasks are in a specific status category Page: Close parent issue when all sub-tasks are closed

Page: Enforce a field (Select List) to be set when another field (Radio

Page: Make different fields mandatory depending on the value of a Select List custom field

Page: Make linked issues, sub-tasks and JQL selected issues progress through its workflows

Page: Make parent issue progress through its workflow

Page: Prevent issue creation if another issue with same field value already exists

Page: Reject duplicated file names in attachments

Page: Require at least one sub-task in status "Resolved" or "Closed" when "Testing required" is selected in Check-Box custom field

Page: Require issue link when resolving as duplicate

Page: Restrict parent issue from closing if it has sub-tasks that were created during a given parent issue status
